That the sum, not to exceed, ONE HUNDRED NINE THOUSAND SEVEN HUNDRED FIFTY SIX DOLLARS (\$109,756), is accepted when tendered from the State of Alaska, Department of Transportation & Public Facilities, and appropriating said grant to the State Categorical Grants Fund (231), Anchorage Police Department, for Youth at Risk Driving Enforcement Program.
