1 A RESOLUTION CONFIRMING AND LEVYING SPECIAL ASSESSMENTS FOR
2 SPECIAL ASSESSMENT DISTRICT NO. 5P97, WHICH PROVIDED ALLEY PAVING
3 IMPROVEMENTS ON THE K STREET/L STREET ALLEY BETWEEN 7TH AVENUE
4 AND 8TH AVENUE, AND SETTING THE DATE OF ASSESSMENT INSTALLMENT
5 PAYMENTS, INTEREST ON UNPAID ASSESSMENTS, AND PROVIDING FOR
6 PENALTIES AND INTEREST IN THE EVENT OF DELINQUENCY

9 THE ANCHORAGE ASSEMBLY RESOLVES:
10

11 Section 1. The improvements authorized in Anchorage Ordinance 97-
12 84 have been completed and actual costs determined. Special assessments are hereby
13 levied against properties benefited by said improvements as set forth in the attached
14 assessment roll prepared for the district.
15

16 Section 2. Timely notice of assessment was sent to each property
17 owner whose property is benefited by the improvements as indicated on the attached
18 assessment roll. Each property owner was also given notice of a Public Hearing to be
19 held before the Municipal Assembly. This provided property owners an opportunity to
20 present objections and/or inequalities in the assessment roll for the district.
21

22 Section 3. In conformance with the notice to the property owners, the
23 Assembly held a Public Hearing on December 17, 2003. At said hearing, all errors
24 and inequalities to which valid objections were raised were corrected. The amounts
25 indicated on the assessment roll are those amounts determined to be assessed. Said
26 amounts are equal to, or less than, the benefit each property derives from the
27 constructed improvements. The assessment roll has been duly certified by the
28 Municipal Clerk.
29

30 Section 4. All assessments and installment interest thereon may be
31 paid in approximately equal annual installments, according to the schedule specified in
32 Assembly Resolution No. 93-179. Annual installments are due and payable on or
33 before the 28th day of February of each year, with the first such installment
34 coming due and being payable on February 28, 2004.

36 Section 5. Interest on the unpaid assessment shall be at the rate equal
37 to the effective interest rate on the last bonds sold to finance similar improvements.

1 Section 6. Assessment installments not paid when due and payable
2 are delinquent beginning on the day following the date when due and payable. A
3 penalty of eight percent (8%) shall be added to any assessment installment not paid
4 before the date of delinquency and both the penalty and the delinquent amount shall
5 draw interest at the rate of eight percent (8%) per annum until paid.


7 Section 7. A special assessment collection charge, as authorized in
8 Anchorage Municipal Code 19.20.265, will be charged to those properties identified in
9 this resolution.



11 Section 8. Within thirty (30) days from the passage of this resolution,
12 the Municipal Treasurer shall mail, postage prepaid, a notice to any owner of property
13 whose assessment, schedule of payments, delinquencies, or amount of penalty and
14 interest has been changed as a result of the hearing on the assessment roll. Not more
15 than sixty (60) or less than thirty (30) days before the date said assessment or the first
16 installment thereof shall become delinquent, the Municipal Treasurer shall mail a
17 payment notice to each property owner, but failure to mail such notice shall in no way
18 affect any liability for assessment levied by this resolution.

SUBJECT: Resolution Confirming and Levying Special Assessments for Special Assessment District 5P97 which provided alley paving improvements on the K Street/L Street Alley between 7th Avenue and 8th Avenue

On June 10, 1997, the Municipal Assembly approved Ordinance No. AO 97-84 creating special assessment district 5P97 for alley paving improvements on the K Street/L Street Alley between 7th Avenue and 8th Avenue. Original project cost was estimated at \$23,256. Project construction is complete and the actual project cost is \$62,765.28. Most of the cost increase was related to easement acquisition, and underestimated excavation, backfill, design and survey costs.

AO No. 97-84 specified that assessments would be the lesser amount of: (1) construction contract costs plus twenty percent (20%) for non-contract costs, plus actual acquisition costs; or (2) the last approved estimate plus ten percent (10%). The second option is the lowest at \$22,000, which is 10% higher than the estimated assessable cost of \$20,000 approved by property owners in the petition. This total assessable amount was used in calculating final assessments for each parcel, which are in turn 10% higher than those approved by property owners.

Information on the proposed final assessments was provided in a letter to property owners and at a public meeting. No concerns were noted.

The Municipality of Anchorage owns three parcels within this district as noted on the attached roll. However, passage of this resolution will have no fiscal impact as voter-approved Road Improvement District bond funds will be used to pay the assessments.

THE ADMINISTRATION RECOMMENDS A PUBLIC HEARING BE SCHEDULED FOR THIS RESOLUTION AND, UPON CONCLUSION OF THE HEARING, APPROVE THE RESOLUTION AND SET THE DATE OF FIRST PAYMENT.
