Subject: Resolution No. 2003-363, Appropriating the State of Alaska Grant Award and a cash contribution from the Municipal General Government Operating Budget for the Child Care Licensing Program in the Department of Health and Human Services.

Mayor

The accompanying Assembly Resolution appropriates Nine Hundred Seventeen Thousand Dollars (\$917,000) from the Alaska Department of Health and Social Services to the State Categorical Grant Funds (231) for the Child Care Licensing Program in the Department of Health and Human Services. This Assembly Resolution also appropriates a cash contribution of One Hundred Nine Thousand Dollars (\$109,000) for the Child Care Licensing Program from the Municipal General Government Operating Budget.

 The Child and Adult Care Program is responsible for licensing child care centers, recommending licensure or denial for family child care homes, and facilitating reviews by other agencies required to approve child care facilities.

In the previous year, the Municipal Child and Adult Care Program served 117 licensed child care centers, which offer Anchorage approximately 7,000 spaces for child care and opened seven new centers. In serving child care homes 2,031 were assisted and 86 were newly recommended. The program investigated 427 child care facility complaints and assisted 929 new applicants.

The State Department of Health and Social Services has funded a portion of these services since 1989. The appropriation of the cash contribution will support the State grant and allow the licensing program to continue serving Anchorage's families. Expenditures are approved from July 1, 2003 to June 30, 2004.
