**A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND APPROPRIATING  
2002 STATE OF ALASKA LEGISLATIVE GRANT FOR RENOVATIONS TO ANCHORAGE  
MUSEUM OF HISTORY AND ART PER SENATE BILL 2006**

WHEREAS, the State of Alaska has appropriated Five Million Dollars (\$5,000,000) to the Municipality of Anchorage as a capital grant per AS 37.05.315 for Anchorage Museum of History and Art; and

WHEREAS, the grant was subject to voter approval of a Statewide general obligation bond for capital projects, and

WHEREAS, voters approved the bonds in a Statewide voter held November 5, 2002; and

WHEREAS, the State of Alaska packaged and sold voter-approved general obligation bonds on April 9, 2003, and

WHEREAS, the Administration and the Assembly have reviewed the grant offered by the State of Alaska; and

WHEREAS, on, December 2, 2003 a duly advertised public hearing was held in accordance with Section 6.10.085 of the Municipal Code; now therefore,

**THE ANCHORAGE ASSEMBLY RESOLVES:**


**Section 1.** That a State grant in the amount of Five Million Dollars (\$5,000,000) is hereby accepted and appropriated to the Areawide Capital Improvement Program Fund (401) for Renovations to Anchorage Museum of History and Art.

**Section 2:** That this resolution shall take effect upon approval by the Assembly.
