AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE ROCKHILL LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 6, 2004 A BALLOT PROPOSITION APPROVING THE CONTINUATION OF SAID LIMITED ROAD SERVICE AREA FOR AN ADDITIONAL PERIOD OF THREE YEARS. ANCHORAGE MUNICIPAL CODE SECTIONS 27.20.320 AND 27.30.590.

WHEREAS the Rockhill Limited Road Service Area was created by Anchorage Ordinance 89-92; and

WHEREAS a showing of interest in continuing said limited road service beyond December 31, 2004 has been made by persons residing in said limited road service area; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. That a ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Section Rockhill Limited Road Service Area at the regular Municipal election on April 6, 2004:

Shall the existence of the Rockhill Limited Road Service area be continued for an additional period of three (3) years after December 31, 2004 until December 31, 2007?

Section 2. That Section 27.30.590 of the Anchorage Municipal Code is hereby amended to read as follows:

27.30.590 Rockhill Limited Road Service Area.


- A. There is established, pursuant to section 9.01 of the Charter, a limited road service area within the municipality to be the Rockhill Limited Road Service Area of the municipality, as outlined on the map located in section 27.30.700.
- B. The Rockhill Limited Road Service Area shall contribute funds expressly for the maintenance of roads commencing on January 1, 1990, and shall end on December 31, 2007 [2004], unless the service area is extended by an affirmative vote of the service area at the regular election of April 2007 [2004]. The mill rate shall not exceed 1.50 mills in any calendar year.

Section 3. Except for Section 2, this ordinance shall become effective upon passage and approval. Section 2 and the proposition contained in Section 1 shall become effective upon certification of the regular election on the proposition called for by this ordinance, but only if that proposition is approved by a majority of the qualified voters voting on the proposition.
