<u>Section 2</u>. That Section 27.30.310 of the Anchorage Municipal Code is hereby amended to read as follows:

27.30.310 Valli Vue Limited Road Service Area.

- A. There is established a limited road service area within the municipality known as the Valli Vue Limited Road Service Area to provide limited road maintenance and repair to the area described on the map locate in section 27.30.700.
- B. Limited road service maintenance and repair within the service area shall end on December 31, 2007 [2004], unless the service area is extended by an affirmative vote of the service area at the regular election of April 2007 [2004]. The mill rate shall not exceed 1.4 mills in any calendar year.

<u>Section 3</u>. Except for Section 2, this ordinance shall become effective upon passage and approval. Section 2 and the proposition contained in Section 1 shall become effective upon certification of the regular election on the proposition called for by this ordinance, but only if that proposition is approved by a majority of the qualified voters voting on the proposition.
