

9 Board shall be and is hereby continued and reestablished as set forth in Anchorage Municipal Code  
10 Section 4.60.180 for an additional period of three (3) years from and after March 31, 2004. During the  
11 period of time from and after March 31, 2004 until the effective date of this ordinance, all actions of the  
12 Animal Control Advisory Board, all appointments thereto and all unexpired terms of its members shall  
13 continue to be and constitute the actions of, appointments to and the unexpired terms of its members, as the  
14 case may be, as if it had not been terminated by operation of law.


