10 for an additional period of three (3) years from and after March 7, 2004. During the period of time from and  
11 after March 7, 2004 until the effective date of this ordinance, all actions of the Investment Advisory  
12 Commission, all appointments thereto and all unexpired terms of its members shall continue to be and  
13 constitute the actions of, appointments to and the unexpired terms of its members, as the case may be, as if it  
14 had not been terminated by operation of law.


16 **Section 2.** Nothing in this ordinance shall be taken as or constitute any approval, ratification,




