
5 THE ANCHORAGE ASSEMBLY ORDAINS:

7 **Section 1.** Pursuant to Anchorage Municipal Code Section 4.05.150, the Youth Advisory Commission
8 shall be and is hereby reestablished as set forth in Anchorage Municipal Code Section 4.60.275 for an
9 additional period of three (3) years from and after March 7, 2004. During the period of time from and after
10 March 7, 2004 until the effective date of this ordinance, all actions of the Youth Advisory Commission, all
11 appointments thereto and all unexpired terms of its members shall continue to be and constitute the actions
12 of, appointments to and the unexpired terms of its members, as the case may be, as if it had not been
13 terminated by operation of law.


15 **Section 2.** Nothing in this ordinance shall be taken as or constitute any approval, ratification,
