AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY RE-ADOPTING ANCHORAGE MUNICIPAL CODE SECTION 17.10.090 PERTAINING TO OFF-LEASH DOG PARK SPACES

WHEREAS, on July 22, 2003, the Anchorage Assembly approved AO 2003-108(S) which allowed for off-leash dog park spaces; and

WHEREAS, Section 4 of AO 2003-108(S) stated that the ordinance would expire on September 30, 2004 unless re-adopted by the Assembly.

NOW, THEREFORE, the Anchorage Municipal Assembly ordains:

That AMC 17.10.090 is hereby re-adopted effective immediately upon passage and approval. That section shall remain in effect only until December 31, 2004 and is automatically repealed on that same date unless the Assembly, in conjunction with approval of the General Government Operating Budget for FY 2005, finds that funds sufficient to implement the four recommendations contained in the Parks and Recreation Commission resolution of August 12, 2004 have been recommended by the Mayor and appropriated by the Assembly in the General Government Operating Budget for FY 2005, and the Mayor has appointed a special advisory committee consisting of a representative each of the Parks and Recreation Department, the Parks and Recreation Commission, and the Animal Control Advisory Board, and two citizens to assist the Administration in preparing a a specific operations plan for the University Lake and Connors Lake Parks by no later than May 10, 2005.

Upon approval of this legislative finding as provided above, AMC 17.10.090 shall become a permanent part of the Anchorage Municipal Code, subject to repeal or modification by subsequent ordinance of the Assembly.
