Subject: Dedication of Excise Tax on Cigarettes and Tobacco Products

At the September 21, 2004, regular Assembly meeting, ordinance serial number AO 2004–131 increasing the tobacco tax was adopted. Proposed AO 2004–146 annually dedicates ten percent of the tax revenue to tobacco cessation and education programs identified by the Department of Health and Human Services. Based on an 8.9 million dollar revenue projection, this equals approximately \$890,000. Dedicating a portion of the revenue to such programs should assist in promoting the public's health and may result in reducing medical and social costs associated with tobacco use.

Accordingly, I urge adoption of ordinance serial number 2004–146.
