1 AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 4.50.070 TO RENAME  
2 THE SCHOOL BUDGET ADVISORY COMMISSION, HAVE THE COMMISSION ADVISE AND  
3 REPORT TO THE MAYOR, SCHOOL BOARD, AND SUPERINTENDENT OF SCHOOLS IN  
4 ADDITION TO THE ASSEMBLY, TO ADD ADDITIONAL POWERS AND DUTIES, AND FOR  
5 OTHER PURPOSES.

8 THE ANCHORAGE ASSEMBLY ORDAINS:

9  
10 **Section 1.** Anchorage Municipal Code section 4.50.070 is hereby amended to read as follows:

11 **4.50.070 Education and Workforce [SCHOOL BUDGET] advisory commission.**

12 There is established an education and workforce [SCHOOL BUDGET]  
13 advisory commission composed of nine members.

14 The members of the commission shall be appointed by the mayor and  
15 confirmed by a majority vote of the assembly. Due consideration shall be given to  
16 geographical distribution. The executive director of the Anchorage Economic  
17 Development Corporation shall serve as an ex officio member of the commission.  
18 [THE REGULAR TERM OF A MEMBER OF THIS BOARD SHALL COMMENCE  
19 ON OCTOBER 15 OF THE YEAR OF APPOINTMENT AND SHALL EXPIRE ON  
20 OCTOBER 14 OF THE YEAR HIS TERM EXPIRES.]

21 The commission shall act in an advisory capacity to the assembly, the mayor,  
22 the school board, and the superintendent of schools and shall have the following  
23 powers and duties:

- 24 A. To make recommendations and give advice to the assembly and the  
25 mayor on the school budget, including but not limited to an annual  
26 report on the school budget to be presented to the assembly at the time  
27 the assembly opens public hearings on the school budget.
- 28 B. To participate with the assembly and the mayor in the review of the  
29 school budget, concluding with any revisions to the annual report at the  
30 close of the public hearings and assembly discussion.
- 31 C. To make such special studies on school budgetary matters as may be  
32 designated by the assembly and the mayor from time to time.
- 33 D. To advise the assembly, the mayor, school board and superintendent on

short and long term strategies on the workforce training and development needs of the municipality.


E. To develop strategies to meet the workforce training and development needs of the municipality.

F. To advise the assembly, mayor, school board, and superintendent on strategies to prepare and support pre-school and school age children and adult students for success in the municipal school system and other educational and vocational programs.


G. To develop reports as deemed necessary related to subsections D, E, and F.

**Section 2.** This ordinance shall be effective immediately upon its passage and approval by the Assembly.
