AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 4.50.070 TO RENAME THE SCHOOL BUDGET ADVISORY COMMISSION, HAVE THE COMMISSION ADVISE AND REPORT TO THE MAYOR, SCHOOL BOARD, AND SUPERINTENDENT OF SCHOOLS IN ADDITION TO THE ASSEMBLY, TO ADD ADDITIONAL POWERS AND DUTIES, AND FOR OTHER PURPOSES.

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. Anchorage Municipal Code section 4.50.070 is hereby amended to read as follows:

4.50.070 Education and Workforce [SCHOOL BUDGET] advisory commission.

There is established an education and workforce [SCHOOL BUDGET] advisory commission composed of nine members.

The members of the commission shall be appointed by the mayor and confirmed by a majority vote of the assembly. Due consideration shall be given to geographical distribution. The executive director of the Anchorage Economic Development Corporation shall serve as an ex officio member of the commission. [THE REGULAR TERM OF A MEMBER OF THIS BOARD SHALL COMMENCE ON OCTOBER 15 OF THE YEAR OF APPOINTMENT AND SHALL EXPIRE ON OCTOBER 14 OF THE YEAR HIS TERM EXPIRES.]

The commission shall act in an advisory capacity to the assembly, the mayor, the school board, and the superintendent of schools and shall have the following powers and duties:

- A. To make recommendations and give advice to the assembly <u>and the mayor</u> on the school budget, including but not limited to an annual report on the school budget to be presented to the assembly at the time the assembly opens public hearings on the school budget.
- B. To participate with the assembly <u>and the mayor</u> in the review of the school budget, concluding with any revisions to the annual report at the close of the public hearings and assembly discussion.
- C. To make such special studies on school budgetary matters as may be designated by the assembly and the mayor from time to time.
- D. To advise the assembly, the mayor, school board and superintendent on

5	F. To advise the assembly, mayor, school board, and superintendent on
