**AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY  
AUTHORIZING AN AMENDMENT TO PORT OF ANCHORAGE TERMINAL  
TARIFF NO. 5 TO ADD AN HOURLY RATE FOR ANCHORAGE POLICE  
DEPARTMENT POLICE SERVICES AT THE PORT.**

WHEREAS, the Military Surface Deployment and Distribution Command Organization has requested the Port of Anchorage incorporate an hourly rate for police services from Anchorage Police Department (APD) in the Port's Tariff No. 5, to enable them to contract for sworn officer protection when deployments are underway; and,

WHEREAS, the Assembly approved AO 2004-139 adding an hourly rate for APD police services to the Anchorage Municipal Code Chapter 9.06; and,


WHEREAS, the Port Commission recommends adding an hourly rate for APD police services of \$100.00 per hour per police officer, which includes APD's hourly rate plus the administrative cost to the Port for scheduling and preparing the APD police services request on behalf of the military; now therefore,

**THE ANCHORAGE ASSEMBLY ORDAINS:**


**Section 1.** The Port of Anchorage's Tariff No. 5 is amended to add an hourly rate of \$100.00 per hour per police officer for APD police services to the military at the Port of Anchorage Terminal.

**Section 2.** This amendment to Tariff No. 5 shall be effective immediately upon passage and approval.

**Subject: AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY  
AUTHORIZING AN AMENDMENT TO PORT OF ANCHORAGE  
TERMINAL TARIFF NO. 5 TO ADD AN HOURLY RATE FOR  
ANCHORAGE POLICE DEPARTMENT POLICE SERVICES AT THE  
PORT.**

The Port of Anchorage was recently named the Nation's 15th Strategic Seaport in the United States primarily due to the Port's importance to the military mission in Alaska, particularly as it relates to the deployment of the 172<sup>nd</sup> Stryker Brigade. The mission of the 172nd Infantry Brigade is to, on order, deploy worldwide, secure a lodgment, and conduct military operations in support of U.S. national interests.

In support of such deployments, the Port of Anchorage received a request from the Military Surface Deployment and Distribution Command Organization (SDDC), 833 Transportation Battalion, to add an hourly rate to Port Tariff No. 5 for Anchorage Police Department (APD) services at the Port terminal at \$100.00 per hour, per officer, which includes an administrative fee of \$9.00 for Port preparation of the request and scheduling, so SDDC may obtain sworn officer protection when such a deployment is underway.

The requested tariff amendment establishes an hourly rate commensurate with the hourly rate for Anchorage Police Department services during an activity or event held in a municipal facility as approved by the Assembly via AO 2004-139 on October 26, 2004. Police services provided to the SDDC shall stipulate that the Anchorage Police Chief shall have the authority to determine the number of officers required for such an event.

The SDDC will submit requests to the Port of Anchorage for sworn officer protection. For their convenience, and at their request, the fee for police services will be included in their Port billing, along with other ancillary services provided. To accommodate the one billing request, a \$9.00 per hour Port administrative fee is added, yielding a total per hour charge of \$100.00 to the SDDC (\$91.00 APD plus \$9.00 Port).

The Police services fee is not expected to have an economic impact on either the Port or the Anchorage Police Department and, therefore, a SEE (Summary of Economic Effects) is not included.

Pursuant to Anchorage Municipal Code section 11.50.030B., the Anchorage Port Commission is charged with promulgating the Port's Terminal Tariff subject to the approval of the Anchorage Municipal Assembly and the Federal Maritime Commission. On

October 22, 2004, the Port Commission unanimously approved Port Commission Resolution R04-04 approving an amendment to Anchorage Tariff No. 5 and recommending the Anchorage Municipal Assembly also adopt the amendment to Anchorage Tariff No. 5.

THE ADMINISTRATION RECOMMENDS THE ASSEMBLY AUTHORIZE AN AMENDMENT TO THE PORT OF ANCHORAGE TERMINAL TARIFF NO. 5 TO ADD AN HOURLY RATE FOR APD POLICE SERVICES AT THE PORT OF ANCHORAGE.

A RESOLUTION APPROVING AMENDMENTS TO ANCHORAGE TERMINAL TARIFF NO. 5 AND RECOMMENDING THAT THE ANCHORAGE MUNICIPAL ASSEMBLY ALSO ADOPT THE AMENDMENT TO ANCHORAGE TERMINAL TARIFF NO. 5.

WHEREAS, pursuant to Anchorage Municipal Code 11.50.030.C, the Anchorage Port Commission is charged with promulgating the Port's Terminal Tariff subject to the approval of the Anchorage Municipal Assembly and the Federal Maritime Commission; and

WHEREAS the Port of Anchorage has received a request from the Military Surface Deployment and Distribution Command Organization, 833 Transportation Battalion to incorporate a Police Officer rate in our tariff so they can utilize this service during a deployment; and

WHEREAS the requested Tariff Amendment is intended to establish an hourly rate of One Hundred Dollars (\$100.00) per hour, per police officer for Port functions including any activity occurring at the Port of Anchorage;

NOW THEREFORE, the Anchorage Port Commission Resolves:

Section 1. That the Port Commission approves the following amendments to the Port of Anchorage Terminal Tariff No. 5:

Section 2. Definitions and Schedule of Charges, Item 225; the schedule is amended to read:

i. Anchorage Police Officer Rates .....\$100.00 per hour  
Established written notice guidelines for requests for police services as follows:  
Written requests received more than ten (10) days in advance of function shall be charged a two (2) hour minimum for each police officer, regardless of function length.


Written requests received ten (10) days or less prior to the function shall be charged a four (4) hour minimum for each police officer, regardless of function length.

The Anchorage Police Chief shall have the authority to determine the number of officers required for an event.

Section 3. This amendment shall be effective upon approval of the Municipal Assembly.
