
10 **Section 1.** That a sum of thirty thousand dollars (\$30,000) of revenue from the Alaska

SUBJECT: A Resolution Appropriating Thirty Thousand Dollars (\$30,000) of Revenue from the State of Alaska Department of Military and Veterans Affairs Division of Emergency Services to the State Categorical Grants Fund 231 to the Project Management & Engineering Department for the Preparation of a Final Anchorage All-Hazard Mitigation Plan.

In August 2003, the Assembly approved AR 2003-268 which appropriated a \$30,000 grant from the Alaska Department of Military and Veterans Affairs Division of Emergency Services for preparation of a draft All-Hazard Mitigation Plan. The draft Plan identified the most significant natural and man-caused hazards to which the community is exposed (such as earthquakes, wildfires, volcanism, windstorms, terrorism), and began assessing the vulnerability of assets and people to the identified hazards, estimating losses due to selected hazard events, and preliminarily identifying mitigation actions to reduce vulnerability and losses from future events. The State of Alaska Division of Emergency Services has granted an additional \$30,000 to complete the foregoing tasks and to administer a public review process for revision and completion of the Plan.

The Federal 2002 Disaster Management Act requires that Anchorage and other communities have a current and updated hazard mitigation plan in place in order to be eligible to receive Hazard Mitigation Program grant funds during a federally declared disaster. These funds are significant and may amount to as much as 20 percent of the total disaster response and recovery costs. These funds are to be used to fund mitigation projects identified in a community's hazard mitigation plan. Completion of the Plan means Anchorage will be eligible to receive the hazard mitigation grant funds when a federally declared disaster occurs.
