**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY AND
MAYOR MARK BEGICH TO NAME THE LOUSSAC LIBRARY ICE
SCULPTURE FOUNTAIN THE "KAY LINTON ICE SCULPTURE
FOUNTAIN" IN HONOR OF HER OUTSTANDING CONTRIBUTIONS AND
DEDICATION TO COMMUNITY SERVICE**

WHEREAS, AMC 3.97 establishes a means of recognizing and honoring persons who have substantially contributed to the Municipality of Anchorage by naming municipal owned building, other fixed facilities, and public places after such persons; and

WHEREAS, under AMC 3.97, this naming action may be initiated by a formal request of the Assembly to the Mayor; and

WHEREAS, Kay Linton dedicated herself to community service; and

WHEREAS, Kay Linton worked tirelessly to organize library programs and to bring speakers, such as Supreme Court Justice Sandra Day O'Connor, to Z.J. Loussac Library; and

WHEREAS, Kay Linton was responsible for obtaining the funding for the BP/Friends of the Library Wish List Program; and

WHEREAS, Kay Linton was instrumental in fostering better communications among the library staff, library support groups, and general public; and

WHEREAS, Kay Linton continued her fund raising efforts for library programs and for the ice sculpture fountain maintenance and repair; and

1 WHEREAS, Kay Linton was named Alaskan of the Year, Outstanding Woman
2 by the Business of Professional Women's Club two-time Chamber of Commerce Club
3 International Woman of Distinction, and a YWCA Woman of Achievement; and

5 WHEREAS, the Mayor named a committee of five to recommend a name for the
6 Ice Sculpture Fountain, and

8 WHEREAS, the Naming Committee has recommended naming the Loussac
9 Library Ice Sculpture Fountain the Mrs. Jack M. (Kay) Linton Ice Sculpture Fountain
10 in recognition of her achievements and contributions to the Library and community.

12 NOW, THEREFORE, the Anchorage Assembly resolves:

14 Section 1. That the Loussac Library Ice Sculpture Fountain be named the Mrs.
15 Jack M. (Kay) Linton Ice Sculpture Fountain.


17 Section 2. That this resolution shall take effect immediately upon passage and
