THE ANCHORAGE ASSEMBLY RESOLVES:



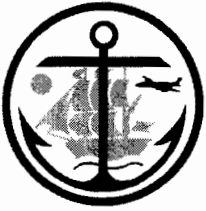
