A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING MAY 7, 2004 AS "POLICE MEMORIAL DAY," AND REMEMBERING AND HONORING THOSE WHO HAVE GIVEN THEIR LIVES IN THE LINE OF DUTY
