A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING WHEN TENDERED THE SUM OF SEVENTEEN THOUSAND SEVEN HUNDRED TWENTY SIX DOLLARS (\$17,726) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES; AND APPROPRIATING SAID GRANT, THIRTY SEVEN THOUSAND EIGHT HUNDRED TWENTY ONE DOLLARS (\$37,821) AS A CONTRIBUTION FROM THE 2004 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151), TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THIS HIGHWAY SAFETY OFFICER TRAINING PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum, not to exceed, SEVENTEEN THOUSAND SEVEN HUNDRED TWENTY SIX DOLLARS (\$17,726), is accepted when tendered from the State of Alaska, Department of Transportation & Public Facilities, and appropriating said grant to the State Categorical Grants Fund (231), Anchorage Police Department, for a Highway Safety Officer Training Program.


Section 2. That the sum, not to exceed, THIRTY SEVEN THOUSAND EIGHT HUNDRED TWENTY ONE DOLLARS (\$37,821), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2004 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**From:** Mayor

**Subject:** State of Alaska, Department of Transportation & Public Facilities, has allocated Federal Funds for a Highway Safety Officer Training Program Grant and local match required. (\$55,547)

The Municipality of Anchorage anticipates receiving a grant from the State of Alaska, Department of Transportation & Public Facilities for a Highway Safety Officer Training Program. This grant will be used to provide accident reconstruction, life saving technique, drug impairment for education professionals, and drug recognition expert training for officers of the Anchorage Police Department.

This grant will be used to pay for training and associated travel costs for traffic and school resource officers. Through increased officer training and awareness of traffic enforcement issues, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

The notice to proceed authorizes \$17,726 from the grantor upon final Federal Budget approval. A special condition of this grant is that the department provide matching funds. The total municipal cost is \$37,821 which has been budgeted in the 2004 Personnel Operating Budget. This grant will begin March 27, 2004 and will end on September 31, 2004.
