A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE PROVIDING FOR THE APPROPRIATION OF A GRANT TOTALING THIRTY FOUR THOUSAND, EIGHT HUNDRED FORTY TWO (\$34,842) DOLLARS FROM THE STATE OF ALASKA, DEPARTMENT OF EDUCATION TO THE STATE CATEGORICAL GRANT FUND (231), OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT FOR THE NET LENDER REIMBURSEMENT PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

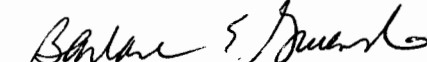
Section 1. That a sum not to exceed THIRTY FOUR THOUSAND, EIGHT HUNDRED FORTY TWO (\$34,842) DOLLARS is hereby appropriated from a grant awarded by the State of Alaska, Department of Education, Division of State Libraries to the State Categorical Grant Fund (231) Office of Economic & Community Development, for the Net Lender Reimbursement grant.

Subject: Appropriation of a State Categorical Grant from the State of Alaska for the NET LENDER REIMBURSEMENT (\$34,842) Program for the Library.

Notification has been received that the Anchorage Municipal Libraries have been awarded a grant by the State of Alaska, Department of Education, Division of Libraries, to the State Categorical Grant Fund (231) Office of Economic and Community Development, for the Net Lender Reimbursement (\$34,842) program for the period of July 1, 2003 through June 30, 2004.

The Net Lender Reimbursement program from the State Library reimburses libraries at \$6.00 per item for loaning more items to other Alaskan libraries than they borrow. These funds will be used to purchase library materials for the Anchorage Municipal Libraries' (AML) collection for the use of AML patrons and (through Interlibrary Loan) for other libraries in Alaska.
