Health Preparedness and Response for Bioterrorism.

The Department of Health and Human Services has received a supplemental grant award from the State of Alaska Department of Health and Social Services providing an additional amount of Thirty Thousand Two Hundred Thirty Dollars (\$30,230). The attached resolution requests appropriation of the additional \$30,230 to the State Categorical Grants Fund (231) for the provision of Public Health Preparedness and Response for Bioterrorism. The period of the grant is from July 1, 2003 to June 30, 2004. Expenditures are approved from July 1, 2003.

Under the terms of the grant the Municipal Department of Health and Human Services will continue to provide and promote the following services, based on the amended supplemental notice received on December 19, 2003:

- increase direct and passive surveillance by medical epidemiologist and public health staff and enhance their response to natural or intentional public health threats and emergencies including day-to-day disease surveillance, investigation and outbreak response activities;
- medical epidemiologist will continue to serve as the MOA public health representative on local and state bioterrorism planning, exercise and response efforts;
- coordinate with the State Division of Public Health to continue assessing and developing
 redundant communication systems within the Municipality of Anchorage related to bioterrorism,
 infectious disease and other public health threats and emergencies; and plan and implement
 bioterrorism preparedness and population-based response measures.
