A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWENTY SIX THOUSAND FOUR HUNDRED FIFTY FOUR DOLLARS (\$26,454) FROM THE ALASKA DIVISION OF HOMELAND SECURITY TO THE STATE CATEGORICAL GRANTS FUND (231) FOR THE DEVELOPMENT OF THE CITIZEN CORPS PROGRAMS THROUGH THE OFFICE OF THE MUNICIPAL MANAGER ON BEHALF OF THE MOA OFFICE OF EMERGENCY MANAGEMENT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of Twenty Six Thousand Four Hundred Fifty Four Dollars (\$26,454) is hereby appropriated from the Alaska Division of Homeland Security to the State Categorical Grants Fund (231) for Citizen Corps programs in the Office of the Municipal Manager.

Section 2. That this resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

7 Assembly Resolution No. AR 2004- 121 appropriating Twenty Six Thousand Four Hundred
8 Fifty Four Dollars (\$26,454) from the Alaska Division of Homeland Security to the State
9 Categorical Grants Fund (231) for the development of Citizen Corps Council activities through
10 the Municipal Manager's office on behalf of the MOA Office of Emergency Management.

12 The Citizen Corps program is a national initiative developed to encourage volunteerism and to
13 link volunteer efforts with public safety programs. The Federal Emergency Management Agency
14 (FEMA) administers Citizen Corps programs and provides funding to states to foster state and
15 local Citizen Corps programs such as Community Emergency Response Teams (CERT),
16 Volunteers in Police Service (VIPS), Neighborhood Watch and Medical Reserve Corps.

18 The Office of the Municipal Manager oversees the administration of AWARE (Anchorage
19 Watchful, Alert and Ready for Emergencies) volunteer programs. In addition, the staff of
20 Municipal Manager's office has served as the key contact for all Anchorage Citizen Corps
21 programs to date.

23 The FEMA 2003 Supplemental Citizen Corps grant will enable the Municipality of Anchorage to
24 link these local efforts (AWARE) more effectively with the national Citizen Corps initiatives in
25 order provide a comprehensive emergency response training module for individuals, families,
26 neighborhoods and businesses. These funds will be used to develop unique Anchorage-based
27 programs that can be used as models for other communities.

29 Expenditures are approved from May 1, 2003 to June 1, 2004.
