A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWO THOUSAND DOLLARS (\$2,000) FROM THE US FOOD AND DRUG ADMINISTRATION TO THE AREAWIDE GENERAL FUND (101), DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR ANTICIPATED TUITION AND REGISTRATION EXPENSES FOR CODE ENFORCEMENT STAFF TO ATTEND LOCAL EDUCATIONAL OFFERINGS.

THE ANCHORAGE ASSEMBLY RESOLVES:


Section 1. That the sum of Two Thousand Dollars (\$2,000) is appropriated from the US Food and Drug Administration to the Areawide General Fund (101) Department of Health and Human Services for anticipated tuition and registration expenses for code enforcement staff to attend local educational offerings.

6 A \$2,000 payment from the United States Food and Drug Administration (FDA) is submitted for
7 appropriation into the Areawide General Fund (101) to enable code enforcement staff in the Food
8 Safety & Sanitation Section, Environmental Services Division, Health and Human Services
9 Department to participate in training and education offerings.
10

11 In February 2002, the MOA Food Safety and Sanitation Program enrolled in the FDA Program
12 Standards, which is a quality assurance tool designed by the FDA to assess food safety programs.
13 The FDA awarded this \$2,000 as payment based on DHHS completing a baseline survey of food
14 establishments in Anchorage using those Standards. This is the second year we have been given this
15 award. Funds were restricted only in that FDA stipulated they be used in support of the food
16 program in the Food Safety & Sanitation Section. We are requesting to use these funds for
17 tuition/registration for Food Safety & Sanitation code enforcement staff to attend educational
18 offerings.
