WHEREAS, the IIMC is currently selecting a city to host its 2009 Annual Conference and Anchorage intends to submit a bid; and


WHEREAS, in 1994, Anchorage hosted the IIMC Annual Conference which was a great success and resulted in a vast economic impact on our city; and

WHEREAS, it is anticipated that between 1,200 and 1,500 delegates and exhibitors will attend this conference expanding our economic base while exploring our city and state.


NOW, THEREFORE, the Anchorage Municipal Assembly resolves:
