THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of One Hundred Nine Thousand Three Hundred Fifty Dollars (\$109,350) from the Federal Emergency Management Agency (FEMA) is herby appropriated to the Federal Categorical Grants (241) Fund for purchase of new emergency response air packs for the Chugiak Volunteer Fire Department.
