6 WHEREAS, the Municipality of Anchorage has administered the Weatherization Program since
7 its inception in 1978; and

9 WHEREAS, the Weatherization Program has extensive experience providing materials and labor
10 to upgrade income-eligible, disabled and elderly persons' dwellings; and

12 WHEREAS, the Municipality of Anchorage has the opportunity to apply to Alaska Housing
13 Finance Corporation for state and federal funds for the continuation of the Weatherization
14 Program.

16 NOW THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

18 **Section 1.** That the Municipality shall apply to the Alaska Housing Finance Corporation for
19 Low Income Weatherization Assistance Program funding to provide weatherization services
20 within the Municipality.

22 **Section 2.** That Denis LeBlanc, Municipal Manager, has authority to sign the grant
23 application on behalf of the Municipality.

25 **Section 3.** This resolution shall take effect immediately upon passage and approval by the
26 Anchorage Assembly.
