A RESOLUTION AUTHORIZING THE MUNICIPALITY TO GRANT AN EASEMENT TO ENSTAR NATURAL GAS COMPANY TO PROVIDE INCREASED GAS VOLUME TO THE NEW EAGLE RIVER HIGH SCHOOL WITHIN SECTION 14, T14N, R2W, SEWARD MERIDIAN, ALASKA, LOCATED BETWEEN THE NEW GLENN HIGHWAY AND YOSEMITE DRIVE AND NORTH OF HILAND ROAD, TAX NOS. 060-041-16, 060-041-17, 060-041-18, 060-061-05, AND 060-061-06

WHEREAS, the Anchorage School District requires that Enstar Natural Gas Company (ENSTAR) provide natural gas service to the new Eagle River High School located within Section 14, T14N, R2W, S.M. Alaska; and

WHEREAS, time is of the essence and in order to provide the necessary underground natural gas service to the school, ENSTAR requires an easement across municipal Maintenance and Operations Department properties; and

WHEREAS, ENSTAR agrees to restore the affected area according to the direction and concurrence of the Municipal Planning Department to encourage rapid revegetation blending along the affected area; and

WHEREAS, the subject easement is found to be of no monetary value, but will provide a necessary service to both the Anchorage School District and the Municipality, now therefore;

THE ANCHORAGE ASSEMBLY RESOLVES:

<u>Section 1.</u> That the Administration is authorized to grant the requested natural gas easement to ENSTAR in the following location:

A general location easement over all that part of Lots 112, 113, 114, 115 and 116 located within Section 14, Township 14 North, Range 2 West, Seward Meridian, Anchorage Recording District, Third Judicial District, State of Alaska. The general location easement shall be reduced to a fifteen-foot-wide (15') natural gas easement centered on the natural gas main line, once installed under, upon, over and through said property, the true location to be determined by field survey and record drawing certified by an Alaskan Licensed Surveyor and recorded at the Anchorage State District Recorder's Office.

Enstar Natural Gas Company (ENSTAR) has been requested by the Anchorage School District to provide gas service to the new Eagle River High School prior to the winter of 2004/2005. The current volume of natural gas service supplied to the school is not sufficient to heat the building during the winter months. The proposed easement for the new 4-inch gas line will cross BLM Small Tract lots 116, 115, 114, 113 and the northwesterly portion of lot 112, terminating at the western right of way limit of Yosemite Drive. These lots are being developed and used by Eagle River Street Maintenance as the Hiland Road Street Maintenance Facility material storage yard.

22 23 Enstar is requesting an interim 15-foot-wide general location easement crossing these lots to facilitate construction of the line before the onset of cold weather. The exact location of the easement will be mutually agreed upon by Street Maintenance and Enstar, and will be reflected in an easement document to be recorded for public record after installation of the line has been completed.

32 33 Installing the line involves crossing a 100-foot-wide non-disturbance vegetative buffer easement along the eastern edge of the northwesterly portion of Lot 112 that was established by the material site plan conditions of approval. Recent history demonstrates that public utilities are allowed to cross the buffer easement to serve public purposes. Enstar agrees to place the eastern portion of the 4-inch gas main, that will cross the buffer easement, within an existing Anchorage Water & Wastewater Utility water corridor Intragovernmental Permit area, and to restore the disturbed area to as natural a condition as can be achieved with the guidance and concurrence of the Municipal Planning Department.

Accordingly, Enstar requires the subject easement within Municipal property as identified on the attached easement document (Exhibit A) and map detail (Exhibit B).

Box 190288, Anchorage, Alaska 99519-0288, its successors and assigns, a NON-EXCLUSIVE right-of-way easement to construct, lay, maintain, operate, alter, repair, remove, and replace pipelines and appurtenance, including metering and regulation facilities, thereto for the transportation of natural gas under, upon, over and through lands which the Grantor owns or in which the Grantor has an interest, situated in the Anchorage Recording District, Third Judicial District, State of Alaska, described as follows:

A blanket easement over all that part of Lots 112, 113, 114, 115 and 116 located within Section 14, Township 14 North, Range 2 West, Seward Meridian, Anchorage Recording District, Third Judicial District, State of Alaska. This easement is given to the Grantee, its successors and assigns, with right of ingress and egress from the premises for the purposes herein granted:



The said Grantor is to fully use and enjoy said premises except for the purposes herein granted to the said Grantee and the said Grantor shall not construct or permit to be constructed any house, structures or obstructions on or over said gas main lines that will interfere with the construction, maintenance, repair or operation of pipelines or appurtenance, including metering and regulation facilities, constructed hereunder and will not change the grade of such pipelines.

Grantee hereby agrees to bury all pipeline improvements to sufficient depth in accordance with Natural Gas Line Safety Standards and to not interfere with cultivation of the soil and agrees to repair or replace damaged landscaping, fences and other improvements which may arise from the construction, maintenance, operation of said lines, and upgrading or addition of new gas lines.



