WHEREAS, these additional combined projects costs not anticipated in 2003 for the current budget year amount to \$248,900; and

WHEREAS, there are sufficient funds in the Heritage Land Bank Fund (221) Balance to support these additional expenses for these projects;

NOW THEREFORE, THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

That TWO HUNDRED FORTY-EIGHT THOUSAND NINE HUNDRED DOLLARS Section 1. (\$248,900) shall be appropriated from the Heritage Land Bank General Fund Balance (221) to the Heritage Land Bank Operating Budget for 2004 professional services expenses on special development project on behalf of the Municipality of Anchorage.

That the 2004 HLB Operating Budget is amended to include appropriation of \$248,900 from Section 2. the Heritage Land Bank Fund Balance for the above-noted expense.

SUBJECT: A Resolution of the Municipality of Anchorage Assembly to Appropriate Two Hundred Forty-Eight Thousand, Nine Hundred Dollars (\$248,900) from the Heritage Land Bank Fund Balance (221) to the Heritage Land Bank Operating Budget for Professional Services Expenses Associated with the Abbott/Bragaw Road Extension, the Downtown Convention Center, and the Tudor Road – Lake Otis Parkway Acquisition Projects.

The Heritage Land Bank was tasked late in 2003-early 2004 with three new projects that were either not sufficiently supported by the current operating budget, or have exceeded those projected amounts:

- 1) Abbott Loop and Bragaw Road Extension (\$65,600 to-date)
- 2) Downtown Convention Center RFP and Study (\$28,000 to-date)
- 3) Tudor Road/Lake Otis Parkway intersection property acquisition and improvements (\$155,300 to-date)

A study by The Boutet Company was contracted through Public Works at \$65,600 for the proposed road extension, and for which HLB has agreed to remit as it includes portions of HLB parcels in the proposed right-of-way for the road extension.

This year, HLB was also tasked with assisting this administration with services associated with the proposed downtown Convention and Civic Center. This includes supporting Project Management and Engineering for a portion of professional services provided by contractors on behalf of this project to review proposals for a new convention center. HLB expects professional services costs at approximately \$28,000, per contractor quote.

Traffic congestion at the intersection of Lake Otis Parkway and Tudor Road has long been a problem for commuters in the Anchorage area, and this Administration has pledged to make every effort to relieve the situation. The Heritage Land Bank has been working closely with a brokerage firm over the past several months to negotiate competitive prices on properties at this intersection. These costs are based on the percentage of the properties' values. Additional services to be paid by HLB for this project include appraisal and legal services. Total expected costs to be incurred by the Heritage Land Bank for this project are currently estimated at \$155,300 (\$152,300 for brokerage fees and \$3,000 for legal consultations).

Funds for these project expenses are available for transfer from the HLB Fund Balance (221).
