#### THE ANCHORAGE ASSEMBLY RESOLVES:

WHEREAS, the current collective bargaining agreement between the Municipality of Anchorage (hereinafter "MOA") and the Anchorage Municipal Employees Association. (hereinafter "AMEA") expires December 31, 2005; and

WHEREAS, the MOA entered into negotiations with AMEA to "get to zero" in 2004 and forego a CPI-U pay increase of 2.7% effective January 1, 2004; and

WHEREAS, AMEA and MOA entered into good faith negotiations that resulted in a contract extension agreement which extends the current collective bargaining agreement through December 31, 2007 and established the wages and working conditions for years 2005, 2006, and 2007 of the bargaining agreement; and

WHEREAS, the members of AMEA have ratified and approved a contract extension negotiated with the MOA extending and amending the collective bargaining agreement through December 31, 2007; and

WHEREAS, Anchorage Municipal Code § 3.70.130 provides for Assembly approval of any negotiated bargaining agreement which has been ratified by the represented employees covered thereunder; and

WHEREAS, it is in the best interest of the MOA and AMEA that this labor agreement be subject to the public review and approval process in order to foster good labor-management relationships; and

WHEREAS, the Administration recommends approval of this negotiated contract extension agreement as set forth in the Assembly Memorandum attached hereto;

**NOW, THEREFORE,** based on the foregoing recitals, the Anchorage Municipal Assembly resolves as follows:

The Municipality of Anchorage (MOA) has reached agreement on a two year extension to the collective bargaining agreement (CBA) with the Anchorage Municipal Employees Association. (AMEA). September 14, 2004, AMEA agreed to extend the CBA through December 31, 2007. In cooperation with Mayor Begich's initiative to "get to zero" in 2004, AMEA gave up a 2.7% CPI-U effective January 1, 2004. Most significant in this extension is the agreement for all AMEA members to participate in the Health Flex Program effective January 1, 2005. Now all CBA's in the Health Plan are in the Health Flex Plan.
