A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY APPROPRIATING FIVE MILLION ONE HUNDRED FIFTY THOUSAND DOLLARS (\$5,150,000) OF MUNICIPALITY OF ANCHORAGE, ALASKA, PERFORMING ARTS CENTER REVENUE BOND PROCEEDS TO THE AREAWIDE GENERAL CIP FUND (401) FOR ROOF REPAIRS AT THE ALASKA PERFORMING ARTS CENTER, SIXTY FIVE THOUSAND TWO HUNDRED TEN DOLLARS (\$65,210) OF REVENUE BOND PREMIUM TO THE AREAWIDE GENERAL CIP FUND (401) FOR PAYMENT OF BOND ISSUANCE COSTS, TWO HUNDRED FIFTEEN THOUSAND DOLLARS (\$215,000) OF MUNICIPALITY OF ANCHORAGE, ALASKA, PERFORMING ARTS CENTER REVENUE BOND PROCEEDS TO THE PAC SURCHARGE REVENUE BOND FUND (301) FOR THE PAYMENT OF DEBT SERVICE, AND THREE THOUSAND FIVE HUNDRED EIGHTEEN DOLLARS (\$3,518) OF REVENUE BOND PREMIUM TO THE PAC SURCHARGE REVENUE BOND FUND (301) FOR THE PAYMENT OF DEBT SERVICE.

THE ANCHORAGE ASSEMBLY RESOLVES:

<u>Section 1:</u> That the sum of \$5,150,000 be appropriated to the Areawide General CIP fund (401) as Performing Arts Center Revenue Bond proceeds for the completion of roof repairs at the Performing Arts Center.

<u>Section 2:</u> That the sum of \$65,210 be appropriated to the Areawide General CIP fund (401) as Performing Arts Center Revenue Bond premium for the completion of roof repairs at the Performing Arts Center.

<u>Section 3:</u> That the sum of \$215,000 be appropriated to the PAC Revenue Surcharge Bond Fund (301) as Performing Arts Center Revenue Bond proceeds for the payment of debt service.

<u>Section 4:</u> That the sum of \$3,518 be appropriated to the PAC Revenue Surcharge Bond Fund (301) as Performing Arts Center Revenue Bond premium for the payment of debt service.

AR No. 2004-255, Appropriating Five Million Three Hundred Sixty-Five Thousand Dollars (\$5,365,000) of Municipality of Anchorage, Alaska, Performing Arts Center Revenue Bond Proceeds and Sixty-Eight Thousand Seven Hundred Twenty-Eight Dollars (\$68,728) of Revenue Bond Premium Related to the Performing Arts Center Revenue Bonds.

On August 3, 2004, the Assembly approved AO 2004-110, authorizing the Municipality of Anchorage to proceed with issuance of Performing Arts Center Revenue Bonds in an amount not to exceed \$6,000,000 for the purpose of repairing and refurbishing the roof on the Alaska Center for the Performing Arts. Revenues for the payment of interest and principal on the bonds shall be from surcharges paid by Performing Arts Center patrons as ordained in AO 2004-93 and described in AM 425-2004.

The Alaska Municipal Bond Bank Authority sold the bonds on September 1, 2004. This resolution appropriates Municipality of Anchorage, Alaska, Performing Arts Center Revenue Bond proceeds for roof repairs at the Performing Arts Center and Revenue Bond premium for payment of bond issuance costs and debt service. The bond premium is allocated and appropriated to the CIP fund (401) on a dollar-for-dollar basis against underwriter discount and bond insurance issuance costs. Any remaining bond premium is allocated to the associated debt service funds to be used for debt service obligations.
