A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS TEMPORARY NON-OBJECTION TO A TRANSFER OF OWNERSHIP AND RELOCATION OF A BEVERAGE DISPENSARY LIQUOR LICENSE FROM H&H DEVELOPMENT DBA HOULIHANS OF ALASKA TO EL TANGO INC. LOCATED AT 4300 OLD SEWARD HIGHWAY.

WHEREAS, El Tango, Inc. D.B.A. El Tango has applied for transfer of ownership and relocation of a beverage dispensary liquor license from H&H Development DBA Houlihans of Alaska #3060; and

WHEREAS, the Assembly is willing to temporarily non-protest the license subject to the conditions stated below.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves that:


Section 1: This body does not protest the transfer of ownership and relocation of the beverage dispensary liquor license from Houlihans #3060 to El Tango located at 4300 Old Seward Highway.

Section 2: This temporary non-objection is not intended to bind the Assembly to a future non-objection of this license.

Section 3: A copy of this resolution may be presented to the Alcoholic Beverage Control Board as proof that the Anchorage Assembly, as the local governing body, has temporarily non-protested the transfer in order to permit the Director of the Alcoholic Beverage Control Board to issue temporary approval of the transfer.

Section 4: This resolution is subject to the terms of the required conditional use of this location.
