> The U.S. Department of Justice, Office of Community Oriented Policing Services, provides units of local government with funds for the partial payment of entry-level salaries and approved fringe benefits for three years for newly hired, additional sworn career law enforcement officers beyond the number of officers that would be hired or employed in the absence of this grant. Officers funded by this grant are to be deployed in and around primary and secondary schools. The COPS in Schools grant program was designed to provide an incentive for law enforcement agencies to build working relationships with schools to use community policing efforts to combat school violence.

The Municipality of Anchorage was awarded funding in the amount of \$500,000 for a three (3) year plus one (1) retention year period. Total projected cost over the four (4) year life of this grant is estimated at \$1,284,768 of which \$784,768 is the required municipal match. As a result of this grant award, the Municipality of Anchorage is able to hire four (4) additional entry level sworn officers.

As a special condition of the grant, four (4) seasoned sworn officers must be deployed in area schools while new entry level officers are trained for patrol duty. Another condition of the grant is that the Municipality's local match is incrementally increased each year, until, at the end of the three (3) year grant cycle, the full cost of the four (4) officers is paid by the department for one (1) full additional local budget period.
