WHEREAS, the Safe Harbor Inn opened its doors three years ago providing transitional housing for individuals and families in need, filling 55 rooms with 120-130 guests, more than half of them children; and

WHEREAS, Safe Harbor Inn works in close consultation with 46 partner agencies and the Anchorage School District; and

WHEREAS, while Safe Harbor Inn considers itself to be in the Hospitality Industry, not a social service agency, in the last three years it has achieved impressive results that any social service agency would be proud of: 70% of guests have moved to permanent housing and are homeless no more; they have provided 65,000 safe and secure bed nights; and


WHEREAS, the 2005 operating budget for Safe Harbor Inn is \$362,500 with only 6 percent provided by public funds and the rest coming from lodging fees paid by guests or their referring agencies and private donations; and

WHEREAS, Safe Harbor Inn operates a beautiful property in a newly revitalized neighborhood, adding value and being a good neighbor.
