

A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE HUNDRED EIGHTY THOUSAND FIVE HUNDRED FIFTY NINE DOLLARS (\$180,559) OF INTEREST REVENUE AND FORTY SEVEN THOUSAND THREE HUNDRED TWENTY SEVEN DOLLARS (\$47,327) OF CONTRIBUTION REVENUE IN THE MISCELLANEOUS OPERATIONAL GRANTS FUND (261) AS A CONTRIBUTION TO THE ANCHORAGE PARKS AND RECREATIONAL SERVICE AREA CAPITAL IMPROVEMENT FUND (461) AND EIGHTEEN THOUSAND TWO HUNDRED EIGHTY SEVEN DOLLARS (\$18,287) OF INTEREST REVENUE IN THE ANCHORAGE PARKS AND RECREATIONAL SERVICE AREA CAPITAL IMPROVEMENT FUND (461) TO THE ANCHORAGE PARKS AND RECREATIONAL SERVICE AREA CAPITAL IMPROVEMENT FUND (461) FOR PAYMENT OF ADDITIONAL IMPROVEMENTS TO THE KINCAID SKI CHALET NOT REIMBURSED UNDER THE 2001 SPECIAL OLYMPICS WORLD WINTER GAMES ALASKA CONTRACT.

WHEREAS, the Municipality entered into a contract to construct improvements to the Kincaid Ski Chalet in preparation for the 2001 Special Olympics World Winter Games; and

WHEREAS, funding for additional improvements constructed relating to the 2001 Special Olympics World Winter Games were not forthcoming from the 2001 Special Olympics World Winter Games Alaska grant; now therefore,

#### THE ANCHORAGE ASSEMBLY RESOLVES:

 <u>Section 1.</u> That a sum of one hundred eighty thousand five hundred fifty nine dollars (\$180,559) from interest revenue from the Miscellaneous Operational Grants Fund (261) be appropriated to the Anchorage Parks and Recreational Service Area Capital Improvement fund (461) for payment of additional improvements to the Kincaid Ski Chalet not reimbursed under the 2001 Special Olympics World Winter Games Alaska contract.

<u>Section 2.</u> That a sum of forty seven thousand three hundred twenty seven dollars (\$47,327) of contribution revenue from the Miscellaneous Operational Grants Fund (261) be appropriated to the Anchorage Parks and Recreational Service Area Capital Improvement fund (461) for payment of additional improvements to the Kincaid Ski Chalet not reimbursed under the 2001 Special Olympics World Winter Games Alaska contract.

<u>Section 3.</u> That a sum of eighteen thousand two hundred eighty seven dollars (\$18,287) of interest revenue be appropriated to the Anchorage Parks and Recreational Service Area Capital Improvement fund (461) for payment of additional improvements to the Kincaid Ski Chalet not reimbursed under the 2001 Special Olympics World Winter Games Alaska contract.

<u>Section 4.</u> That this resolution shall take effect immediately upon passage and approval.

During 2000, the 2001 Special Olympics World Winter Games Alaska organization awarded a contract to the Municipality of Anchorage for improvements to Kincaid Ski Chalet in preparation for the 2001 Special Olympics World Winter Games. There are \$255,464 of Kincaid improvement expenditures which were not funded under this contract due to the timing of the Municipality of Anchorage's reimbursement request. The 2001 Special Olympics World Winter Games Alaska organization was dissolved and no alternate methods for reimbursement are available.

This appropriation, in addition to \$9,291 in previously appropriated funds, will close out the project.
