Appropriating to the State Categorical Grants fund (231) a grant of \$100,000 from U.S. Department of Transportation through the Alaska Department of Transportation and Public Facilities for Coordinated Senior and ADA (Americans with Disabilities Act) Transportation Services within the Municipality of Anchorage.

The purpose of this memorandum is to ask for Assembly approval for the Municipality of Anchorage to accept a grant funding senior and ADA transportation. The Municipality of Anchorage received a grant award notification from the Alaska Department of Transportation and Public Facilities. The grant is in the amount of \$100,000 and covers the period of July 1, 2004 through June 30, 2006. This Federal Transit Administration Section 5310 grant through the Alaska Department of Transportation and Public Facilities assists in the funding of the AnchorRIDES, a coordinated transportation service for Anchorage's senior citizens and individuals with disabilities. The required 20% match, \$25,000, is provided through \$2.50 fares collected from clients served by this grant, and the collected fares are expended for transportation services. Additionally, fuel, staff time and contractual paratransit services will be provided as 'in-kind' matching to this grant from the 2005 and 2006 Operating Budgets of the Public Transportation Department.
