## ANCHORAGE, ALASKA AO No. 2005- 48

AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 12.25.040 TO REDUCE THE 2005 MAXIMUM ATTAINABLE TAX REVENUE BY AN AMOUNT ATTRIBUTABLE TO EXCLUSION OF THE EAGLE RIVER STREET LIGHT SERVICE AREA FROM THE 2005 BUDGET.

### THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1</u>. Anchorage Municipal Code section 12.25.040 is amended to add a new subsection 12.25.040J. as follows (the remainder of the section is not affected and therefore not set out):

## 12.25.040 Computation of maximum attainable tax revenue amount.

The estimate of maximum attainable tax revenue (next year revenue available) is computed for the next fiscal year according to the following procedures:

J. The fiscal year 2005 maximum attainable tax revenue calculated pursuant to this section shall be reduced by an amount equal to the amount of revenue attributable to the Eagle River Street Light Service Area in the approved 2005 municipal operating budget.

<u>Section 2</u>. This ordinance shall be effective immediately upon passage and approval by the Assembly.

### PUBLIC SECTOR ECONOMIC EFFECTS:

The 2005 approved budget for the Eagle River Street Light Service Area includes an estimated tax revenue of \$220,250. With an estimated assessed valuation for the Eagle River Street Light Service Area of \$752 million, the preliminary tax rate was 0.29 mills. These taxes were within the Municipal Tax Limitation at the approval of the 2005 Budget.

Anchorage Municipal Code (AMC) section 27.30.560 sets the tax levy at a rate not to exceed .50 mills, allowing taxes of approximately \$376,000 to be collected. This ordinance allows those taxes to be excluded from the Municipal Tax Limitation, reducing the maximum allowable tax revenue for 2005 as defined in AMC section 12.25.040. This allows the Eagle River Street Light Service Area budget to be set at an amount not to exceed \$376,000 in tax cost, as determined by the Maintenance and Operations Department, in the 2005 budget while being excluded from the Municipal Tax Limitation.

#### PRIVATE SECTOR ECONOMIC EFFECTS:

The 2005 preliminary tax levy represents an estimated cost of \$29 per \$100,000 of assessed valuation. If the tax levy is increased to the maximum .50 mills, taxpayers within the Eagle River Street Light Service Area will pay an amount not to exceed the .50 mills tax levy for street light maintenance and operations, an amount approximately \$50 per \$100,000 of assessed valuation.
