THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1:** That Anchorage Municipal Code Section 2.30.070 is amended to read as follows:

2.30.80 Voting.

\* \* \* \* \* \* \* \* \* \*

- H. A member of the A[a]ssembly, who will be absent from a legislative meeting, including a legislative executive session and who has obtained an excused absence from the Chair [, DUE TO SICKNESS, ACCIDENT, OR OTHER UNFORESEEN EMERGENCY, OR WHO IS OUTSIDE OF THE MUNICIPALITY ON OFFICIAL MUNICIPAL TRAVEL/BUSINESS], may participate in and vote at the meeting by telephone or other electronic means under the following circumstances:
  - 1. The meeting is held with a quorum of members physically present;
  - 2. Reasonable technical capabilities are available at the meeting location to allow the member to participate by teleconference, to include being able to hear and engage in discussion, and being audible to all persons participating in the meeting;
  - 3. Prior to the meeting, maximum efforts are made to ensure that the member participating by teleconference is provided with the meeting agenda and other pertinent documents to be discussed and/or acted upon; and
  - 4. All votes taken at the meeting are by roll call.
