SUBJECT: AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION

3.88.030 TO DESIGNATE THE MUNICIPAL TREASURER AS THE PROGRAM ADMINISTRATOR OF THE PREFUNDING INVESTMENT BOARD

The accompanying ordinance is submitted at the request of the Police and Fire Retiree Medical Trust and the Prefunding Investment Boards. The ordinance proposes to designate the Municipal Treasurer as Administrator of the Prefunding Investment Board. As specified in section 3.88.030C., this role is currently performed by the Plan Administrator of the Police and Fire Retiree Medical Funding Program. However, growth in the number of police and fire retirees has increased the workload for the Plan Administrator to the point where it is not possible for one position to adequately support administration of both the retiree medical plan and the Prefunding Investment Program. In addition, the training and experience required to support the Prefunding Investment Program's growing investment portfolio is different than required to administer the benefits plan.

The Municipal Treasurer is well qualified and situated to assume the role of Prefunding Investment Board Administrator. The Treasurer currently serves in a similar capacity for the Municipal Trust. The Treasurer also currently serves on the Prefunding Investment Board and is increasingly called upon to assist the Plan Administrator with Prefunding Investment Board related duties. If the ordinance amending section 3.88.030C is approved, the Treasurer will step down as a member of the Prefunding Investment Board, and assume the role of Prefunding Investment Board Administrator.
