AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING ANCHORAGE MUNICIPAL CODE SECTION 3.70.050 PERTAINING TO THE MEMBERSHIP OF THE EMPLOYEE RELATIONS BOARD AND ANNUAL ELECTION OF THE CHAIR.

THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1.</u> Anchorage Municipal Code section 3.70.050A is hereby amended by adding additional language to read as follows:

3.70.50 Employee Relations Board

A. Established: membership. There is established an impartial body, the employee relations board of the municipality. The board is made up of three impartial members appointed by the mayor and confirmed by the assembly in public hearing. The board must include a member with a background in management, a member with a background in labor, and a member from the general public. The board shall annually select a chair from among its members to serve a term of one year. Confirmation hearings shall be preceded by at least two weeks' notice to representatives of each municipal bargaining unit of the proposed appointment. The employee relations board reports jointly to the mayor and the assembly.

Section 2: This ordinance shall become effective upon passage and approval. The ordinance shall have prospective effect only and shall only apply to the appointment of new members.
