The State of Alaska has awarded FY 2005 supplemental grant funding to the Municipality of Anchorage to support provision of essential human services at the Catholic Social Services Clare House Shelter. The Municipal Department of Health and Human Services will sub-award grant funding in the amount of \$10,041 to Clare House for shelter services; the grant period is July 1, 2004 through June 30, 2005.

These grant funds are to supplement and combine with FY 2005 Human Services Matching Grant (HSMG) funding, also received by the Municipality from the State of Alaska. To comply with these requirements, this grant and reporting requirements are combined with HSMG funding in one sub-grant award to Clare House. The 30% local matching fund requirement is met with Federal CDBG Public Service funding.
