- 7. Installation of highway illumination along the Glenn Highway from the Knik River Bridge to Eagle River.

- 8. Funding authorization for the Governor's Fiscal Year 2006 Transportation Initiative.
- 9. Full funding of mandated Senior Citizen and Disabled Veterans Tax Exemption programs.
