A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING A ONE HUNDRED TWENTY-FOUR THOUSAND FOUR HUNDRED TWENTY DOLLAR (\$124,420) CONTRIBUTION OF FIRST QUARTER ADJUSTED 2004 TAX REVENUES APPROVED IN THE 2004 GENERAL OPERATING BUDGET FROM THE CHUGIAK, BIRCHWOOD, EAGLE RIVER RURAL ROAD SERVICE AREA (CBERRRSA) FUND 119 TO THE CBERRRSA CAPITAL IMPROVEMENT PROGRAM FUND 419 FOR ROAD AND DRAINAGE CAPITAL IMPROVEMENT PROJECTS WITHIN THE CBERRRSA.

Section 1. That a One Hundred Twenty-Four Thousand Four Hundred Twenty Dollar (\$124,420) contribution of first quarter adjusted 2004 tax revenues approved in the 2004 General Operating Budget from the CBERRRSA Fund 119 is hereby appropriated to the CBERRRSA Capital Improvement Program Fund 419 for road and drainage capital improvement projects within CBERRRSA.

Section 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.
