A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF TWENTY EIGHT THOUSAND SEVEN HUNDRED EIGHTY NINE DOLLARS (\$28,789) FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ALASKA STATE TROOPERS AND APPROPRIATING ONE THOUSAND FIVE HUNDRED TEN DOLLARS (\$1,510) AS A CONTRIBUTION FROM THE 2005 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) FOR A JUVENILE OFFENDER SUPERVISION PROGRAM GRANT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of TWENTY EIGHT THOUSAND SEVEN HUNDRED EIGHTY NINE DOLLARS (\$28,789), is appropriated from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, to the State Categorical Grants Fund (231) for Juvenile Offender Supervision.

Section 2. That the sum of ONE THOUSAND FIVE HUNDRED TEN DOLLARS (\$1,510) is appropriated from the 2005 Anchorage Police Operating Budget, Anchorage Metropolitan Police Service Area Fund (151) as a contribution to the State Categorical Grants Fund (231), Juvenile Offender Supervision Program Grant.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, of a Juvenile Offender Supervision Program Grant (\$30,299).

The Municipality of Anchorage has received from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, a Juvenile Offender Supervision Grant in the amount of \$28,789.

This grant, a Project Safe Neighborhoods Project, will be used by the Anchorage Police Department to supervise a modified probation program involving juveniles on probation or associated with weapons violations.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$1,510 which is funded as a contribution from the 2005 Police Operating Budget. This grant began on July 1, 2004 and will end on August 31, 2007.
