

The Administration requests Assembly approval for the appropriation of a grant of \$10,000 from the Anchorage Women's Club to provide for the purchase of additional defibrillators for the Anchorage Police Department.

This grant will provide for the purchase of additional defibrillators for use by patrol officers of the Anchorage Police Department. By deploying automatic defibrillators in active patrol cars, the citizens of Anchorage can enjoy a greater sense of security due to the increased response capabilities of on duty patrol officers. There is no Municipal fund match requirement for this grant. There is no specific time frame for expenditure of grant funds.
