
THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum not to exceed FOURTEEN THOUSAND FOUR HUNDRED AND SEVENTY FIVE DOLLARS (\$14,475) in proceeds from donations from Anchorage Library Foundation, The Rasmuson Foundation and numerous citizens is hereby appropriated to the Miscellaneous Operational Grant Fund (261), Department of Economic and Community Development, for the purchase of library books and materials.

**Subject:** Appropriation of the Anchorage Library Foundation's Donation of (\$3,000) to the Municipal Library for the purchase of Adult Library Books and Materials, Rasmuson's Donation of (\$10,000) for the purchase of children's Library Books and Materials and (\$1,475) of citizen donations for the purchase of unspecified Library Books and Materials.

Anchorage Municipal Libraries has received THREE THOUSAND DOLLARS (\$3,000) from the Anchorage Library Foundation, TEN THOUSAND (\$10,000) from the Rasmuson Foundation and ONE THOUSAND FOUR HUNDRED SEVENTY FIVE DOLLARS (\$1,475) from numerous citizens. It is requested that THREE THOUSAND DOLLARS (\$3,000) be directed toward the purchase of adult library books and materials, TEN THOUSAND (\$10,000) directed toward purchases for the children's collection and ONE THOUSAND FOUR HUNDRED SEVENTY FIVE DOLLARS (\$1,475) be directed toward the purchase of unspecified library books and materials. To accomplish this, appropriation of this amount as a miscellaneous operational grant is requested.
