1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE  
2 MILLION TWO HUNDRED SIXTY FIVE THOUSAND DOLLARS (\$1,265,000) OF  
3 REVENUES FROM WITHIN THE AREAWIDE GENERAL CAPITAL IMPROVEMENT  
4 FUND (401), THREE HUNDRED EIGHTY FIVE THOUSAND DOLLARS (\$385,000) OF  
5 REVENUES FROM WITHIN THE ANCHORAGE PARKS AND RECREATION CAPITAL  
6 IMPROVEMENT FUND (461), AND THIRTY FIVE THOUSAND DOLLARS (\$35,000)  
7 FROM WITHIN THE CHUGIAK-EAGLE RIVER PARKS AND RECREATION SERVICE  
8 AREA CAPITAL IMPROVEMENT FUND (462) FOR FACILITY AND EQUIPMENT  
9 IMPROVEMENTS AT THE ALASKA CENTER FOR THE PERFORMING ARTS, WILLIAM  
10 A. EGAN CIVIC AND CONVENTION CENTER, GEORGE M. SULLIVAN ARENA, BEN  
11 BOEKE AND DEMPSEY ANDERSON ICE ARENAS, ANCHORAGE GOLF COURSE,  
12 AND THE HARRY J. MCDONALD MEMORIAL CENTER.

15 **THE ANCHORAGE ASSEMBLY RESOLVES:**

16  
17 **Section 1:** That the sum of One Million Two Hundred Sixty Five Thousand Dollars  
18 (\$1,265,000) is appropriated from within the Areawide General Capital Improvement Fund  
19 (401) for 2005 improvements to the Alaska Center of the Performing Arts, William A. Egan  
20 Civic and Convention Center, George M. Sullivan Arena and the Anchorage Golf Course.

21  
22 **Section 2.** That the sum of Three Hundred Eighty Five **Thousand** Dollars (\$385,000) is  
23 appropriated from within the Anchorage Parks & Recreation Capital Improvement Fund  
24 (461) for 2005 improvements to the Ben Boeke and Dempsey Anderson Ice Arenas.

25  
26 **Section 3.** That the sum of Thirty Five Thousand Dollars (\$35,000) is appropriated from  
27 within the Chugiak-Eagle River Parks & Recreation Service Area Capital Improvement  
28 Fund (462) for 2005 improvements to the Harry J. McDonald Memorial Center.

30 **Section 4.** That this Resolution shall become effective immediately upon passage and  
31 approval by the Anchorage Assembly.
