8 **WHEREAS**, the Girdwood Board of Supervisors adopted a resolution in support of a grant
9 application to the Denali Commission to partially fund a Multi-Use Facility for a Girdwood
10 Community Center and Library;

12 **WHEREAS**, the Anchorage Assembly supports the resolution adopted by the Girdwood
13 Board of Supervisors to participate in a grant program to provide partial funding for
14 construction of a Multi-Use Facility in Girdwood; now, therefore,

16 **THE ANCHORAGE ASSEMBLY RESOLVES:**


- 18 1. The Anchorage Assembly endorses the participation of the Municipality in a grant
19 proposal for a Multi-Use Facility in Girdwood for a community center and library,
20 commits to fulfilling the responsibilities and duties assigned to the Municipality in the
21 proposal;

- 23 2. The Municipality commits to sustaining the facility and the programs to be offered
24 within it;

- 26 3. The Municipality commits to an "open-door" policy to assure the facility will provide
27 service to all who seek and can pay for such services;

- 29 4. The Mayor, or his designee, is hereby authorized to negotiate and execute any and
30 all documents required for granting and managing funds on behalf of this project in
31 conformance with all requirements set by the Denali Commission and the State of
32 Alaska; and

- 1 5. The Mayor, or his designee, is also authorized to execute subsequent amendments
2 to the grant agreement to provide for adjustments to the project within the scope of
3 services or tasks, based on the needs of the project.
