A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING REVENUE WITHIN THE ANCHORAGE PARKS AND RECREATION SERVICE AREA CAPITAL IMPROVEMENT FUND (461); TWO HUNDRED TWENTY NINE THOUSAND SEVEN HUNDRED SIXTY THREE DOLLARS (\$229,763) FOR IMPROVEMENTS TO ABBOTT LOOP COMMUNITY PARK; EIGHTY THOUSAND THREE HUNDRED DOLLARS (\$80,300) FOR IMPROVEMENTS TO RUSSIAN JACK SPRINGS PARK; AND, ONE HUNDRED THIRTY TWO THOUSAND DOLLARS (\$132,000) FOR DEVELOPMENT OF STRATEGIC PLANS FOR CAPITAL IMPROVEMENTS TO MUNICIPAL PARKS.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of Two Hundred Twenty Nine Thousand, Seven Hundred Sixty Three Dollars (\$229,763) received from AWWU for the compensation for taking parkland in Far North Bicentennial/Hillside Park is appropriated to the Anchorage Parks and Recreation Service Area Capital Improvement Fund (461) for the purpose of improvements to Abbott Loop Community Park.

Section 2: That the sum of Eighty Thousand, Three Hundred Dollars (\$80,300) received from the State of Alaska for compensation for a portion of Russian Jack Springs Park taken in 1988 for Boniface Parkway Road right-of-way is appropriated to the Anchorage Parks and Recreation Service Area Capital Improvement Fund (461) for the purpose of improvements to Russian Jack Springs Park.

Section 3: That the sum of One Hundred Thirty Two Thousand Dollars (\$132,000) in interest earnings and other miscellaneous revenues of the Anchorage Parks and Recreation Service Area Capital Improvement Fund is appropriated to the Anchorage Parks and Recreation Service Area Capital Improvement Fund (461) for the purpose of developing strategic plans for capital improvements in the Anchorage Parks and Recreation Service Area.
