**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND HONORING  
DAPHNE D. HAMBROOK FOR HER 30 YEARS OF SERVICE WITH THE MUNICIPALITY OF  
ANCHORAGE**

WHEREAS, on October 7, 1974, Daphne D. Hambrook began her initial employment with the Municipality of Anchorage working as a Principal Clerk in the Finance Department, and was subsequently promoted to higher level positions in Treasury culminating with her final position as Cash Management Supervisor; and

WHEREAS, on March 1, 1991, Daphne became the Senior Office Associate for Transit Operations; and

WHEREAS, on January 24, 2000, Daphne became a Junior Accountant with the Anchorage Water & Wastewater Utility (AWWU); and

WHEREAS, during her 30 years with the Municipality, Daphne has spent numerous hours working with nonprofit organizations and volunteering her time as a member of the Board of Directors of the Denali Federal Credit Union, and receiving the Alaska Credit Union League's Outstanding Volunteer of the Year in 1992. In 1999, Daphne received the Mayors Award for Public Service, Outstanding Volunteer Service, as Runner Services Co-Chair of the Mayor's Midnight Sun Marathon Committee; and, the same year, originated the Stuff the Bus campaign and co-chaired the Bus Rodeo; and

WHEREAS, in 1986, Daphne's suggestion to the Municipality's Employee Incentive Committee, recommending Municipal payroll be printed on laser machines, eliminating man hours, decreasing processing time and increasing cost effectiveness, was implemented later that year; and

WHEREAS, Daphne was recognized as People Mover's 1997 Employee of the Year, and nominated for the Municipality's 1997 Employee of the Year. Daphne was also Transit's Employee of the Month for June 1992. In 2002, Daphne and the AWWU Accounting Section were recognized as the Work Unit of the Quarter for 2<sup>nd</sup> Quarter 2002.
