A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF THREE THOUSAND FIVE HUNDRED EIGHTY TWO DOLLARS (\$3,582) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES AND SIX THOUSAND THREE HUNDRED FIFTY DOLLARS (\$6,350) AS A CONTRIBUTION FROM THE 2005 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THE ACCIDENT RECONSTRUCTION TRAINING PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of THREE THOUSAND FIVE HUNDRED EIGHTY TWO DOLLARS (\$3,582), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Accident Reconstruction Training Program.

Section 2. That the sum of SIX THOUSAND THREE HUNDRED FIFTY DOLLARS (\$6,350), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2005 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of an Accident Reconstruction Training Program Grant and local match required. (\$9,932)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for an Accident Reconstruction Training program. This grant will be used to provide accident reconstruction training to the Serious Traffic Accident Response Team during the period April 25, 2005 thru April 29, 2005.

This grant will be used to reimburse travel and training costs related to the Accident Reconstruction Training Program in Jacksonville, Florida. This training will enable members of the Serious Traffic Accident Response Team to provide more detailed scene analysis during accident reconstruction processing.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$6,350, which has been budgeted in the 2005 Police Operating Budget. This grant will begin on April 25, 2005 and end on April 29, 2005.
